



Based on State guidance and local considerations, at this time the following Monterey County residents are eligible to receive COVID-19 vaccine:


- Health care workers, long-term care residents, and emergency services personnel
- Residents 65 years and older
- All residents who are at risk of exposure while working in <u>food</u>, <u>agriculture</u>, <u>childcare</u>, <u>education</u>, <u>and emergency services</u>.  - Information about the process in place by the California
 Department of Public Health for vaccinating K-12 teachers.

Vaccine supplies are extremely limited. Not everyone eligible for vaccination may be able to schedule an appointment until supplies increase.

- August 28, 2020 California has a new blueprint for reducing COVID-19 in the state with revised criteria for loosening and tightening restrictions on activities. Find out how businesses and activities can open in counties statewide beginning on August 31.
- August 18, 2020 Carmel Fire and Dolan Fire start.
- August 18, 2020 Monterey County Board of Supervisors ratified a proclamation of the existence of a local emergency due to the River Fire. Fire at 10% containment.
- August 17, 2020 Governor Gavin Newsom secured a Fire Management Assistance Grant (FMAG) from the Federal Emergency Management Agency (FEMA) to help ensure the availability of vital resources to suppress the River Fire burning in Monterey County. <u>More information</u>.
- August 17, 2020 Evacuation warnings issued to the surrounding communities. Evacuation Center at Buena Vista Middle School and Carmel Valley Library closed. Evacuation Center at Toro Park School Opens.

- August 16, 2020 River Fire starts of off Pine Canyon southeast of Salinas. Evacuation orders and warnings issued to the surrounding communities.

- July 13, 2020 Governor expands the closure of indoor operations in Monterey County. ALL counties must close indoor operations in these sectors: Dine-in Restaurants (indoor); Wineries and Tasting Rooms (indoor); Movie Theater (indoor); Family Entertainment Centers (indoor); Zoos and Museums (indoor); Cardrooms (indoor); Closure of all brewpubs, breweries, bars, and pubs (indoor and outdoor).
