



New Cases, Cumulative Cases, and Cases Released from Isolation






MONTEREY COUNTY SHERIFF'S OFFICE JAIL INMATE COVID DATA



Who Is Eligible Now

Based on State guidance and local considerations, at this time the following Monterey County residents are eligible to receive COVID-19 vaccine:

- Health care workers, long-term care residents, and emergency services personnel
- Residents 65 years and older
- All residents who are at risk of exposure while working in <u>food</u>, <u>agriculture</u>, <u>childcare</u>, <u>education</u>, <u>and emergency services</u>. The California Department of Public Health website provides a summary of essential workers eligible to receive COVID-19 vaccine. - <u>English</u> *Spanish available soon*
 - Information about the process in place by the California
 Department of Public Health for vaccinating K-12 teachers.

Vaccine supplies are extremely limited. Not everyone eligible for vaccination may be able to schedule an appointment until supplies increase.

- Persons ages 16 64 with a medical condition or disability that puts them at high risk for morbidity and mortality as defined by the California Department of Public Health.



- March 16, 2021-Monterey County has met the requirements to move into the Red Tier of the Blueprints for a Safer Economy. The Monterey County Health Officer announced today that the County will continue to align with the State's framework and allow activities open in Red Tier counties to resume, effective March 17th. <u>More information</u>

- August 18, 2020 Carmel Fire and Dolan Fire start.
- August 18, 2020 Monterey County Board of Supervisors ratified a proclamation of the existence of a local emergency due to the River Fire. Fire at 10% containment.

- August 17, 2020 Governor Gavin Newsom secured a Fire Management Assistance Grant (FMAG) from the Federal Emergency Management Agency (FEMA) to help ensure the availability of vital resources to suppress the River Fire burning in Monterey County. <u>More information</u>.

- August 16, 2020 River Fire starts of off Pine Canyon southeast of Salinas. Evacuation orders and warnings issued to the surrounding communities.

ALL counties must close indoor operations in these sectors: Dine-in Restaurants (indoor); Wineries and Tasting Rooms (indoor); Movie Theater (indoor); Family Entertainment Centers (indoor); Zoos and Museums (indoor); Cardrooms (indoor); Closure of all brewpubs, breweries, bars, and pubs (indoor and outdoor).
