



- January 13, 2021 Governor Newson announced the statie is prioritizing individuals 65 and older to receive the vaccine.
- January 8, 2021- Monterey County remains under the State Regional Stay at Home Order. <u>More information</u>
- December 17, 2020 First COVID-19 vaccines in Monterey County administered.
- December 13, 2020 Health Officer State Order takes effect at 10:00 p.m. and will continue until 6:00 a.m. January 11, 2021.
- December 9, 2020 <u>Health Officer Stay At Home Order</u> Issued.
- November 19, 2020 State issues limited Stay at Home Order to slow spread of COVID-19. <u>More Information</u>
- November 4, 2020 Monterey County's Tier Adjustment Request Denied. <u>More information</u>.
- October 18, 2020 Coleman Fire starts north of Fort Hunter Ligget and near the Dolan Fire. Evacuation orders and warnings issued to the surrounding communities.
- September 5, 2020 Carmel Fire and River Fire 100% Containment.
- August 28, 2020 California has a new blueprint for reducing COVID-19 in the state with revised criteria for

loosening and tightening restrictions on activities. Find out how businesses and activities can open in counties statewide beginning on August 31.

- August 18, 2020 Carmel Fire and Dolan Fire start.
- August 18, 2020 Monterey County Board of Supervisors ratified a proclamation of the existence of a local emergency due to the River Fire. Fire at 10% containment.
- August 17, 2020 Governor Gavin Newsom secured a Fire Management Assistance Grant (FMAG) from the Federal Emergency Management Agency (FEMA) to help ensure the availability of vital resources to suppress the River Fire burning in Monterey County. <u>More information</u>.
- August 17, 2020 Evacuation warnings issued to the surrounding communities. Evacuation Center at Buena Vista Middle School and Carmel Valley Library closed. Evacuation Center at Toro Park School Opens.
- August 16, 2020 Evacuation Centers opens at Carmel Valley Library and Buena Vista Middle School.
- August 16, 2020 River Fire starts of off Pine Canyon southeast of Salinas. Evacuation orders and warnings issued to the surrounding communities.
- July 13, 2020 Governor expands the closure of indoor operations in Monterey County. ALL counties must close indoor operations in these sectors: Dine-in Restaurants (indoor); Wineries and Tasting Rooms (indoor); Movie Theater (indoor); Family Entertainment Centers (indoor); Zoos and Museums (indoor); Cardrooms (indoor); Closure of all brewpubs, breweries, bars, and pubs (indoor and outdoor). <u>More information.</u>
